

MARUTI FENCE LIMITED LIFETIME WARRANTY

Maruti Technology Inc., doing business as Maruti Fence (“Maruti Fence”), of Kissimmee, Florida, warrants to the original purchasing homeowner (the “Purchaser”) that its vinyl fence products — including panels, posts, rails, pickets, caps and gates manufactured by Maruti Fence (the “Products”) — will be free from manufacturing defects, including peeling, flaking, blistering and corroding, when subject to normal and proper use, subject to the terms and conditions below.

Lifetime Residential Coverage

Should any manufacturing defect occur in the Products during the lifetime of the Purchaser (and provided the Purchaser still owns the home on which the Products are installed at the time the defect is reported), Maruti Fence will, at its sole option, repair or replace the defective Product or the defective parts of the Product, or refund the amount paid by the Purchaser for the defective Product. Because Maruti Fence manufactures every profile in its own Kissimmee plant, warranty claims are handled directly by the manufacturer — not through a dealer or distributor.

Weathering and Color

Maruti Fence products are co-extruded with a weatherable capstock containing titanium dioxide (TiO₂) for UV resistance in the Florida sun. Maruti Fence warrants the Products against excess fading beyond Normal Weathering during the applicable warranty period where such fading is caused by a manufacturing defect. “Normal Weathering” means exposure to sunlight and extremes of weather and atmosphere, which will cause any colored surface to gradually fade, chalk, or accumulate dirt or stains. The Products are not warranted against discoloration or other damage caused by air pollution (including metal oxides or metallic particles), mold, mildew, harmful chemicals (by exposure or cleaning), or Normal Weathering itself.

Non-Residential Installations

Where Products are purchased by or installed on property owned by a corporation, governmental agency, partnership, trust, religious organization, school, condominium, homeowner association, cooperative housing arrangement, apartment building, or any premises other than a single-family home used by an individual homeowner as a primary residence, the limited warranty period is twenty (20) years from the date of purchase.

Limitations

In the event of any repair or replacement under this limited warranty, Maruti Fence shall not be liable for labor charges or other expenses incurred in connection with removal or installation of the original or replacement Product. Maruti Fence supplies material only and does not install; this warranty does not cover installation or defects caused by installation. If a Product is repaired or replaced, the original warranty applies to the repaired or replaced Product for the balance of the original warranty period only. Coverage under this warranty ends automatically upon the earlier of the sale of the property or the death of the last of the Purchasers, and is not transferable.

This Warranty Is Void If

(a) improper installation or application techniques are used, including failure to follow the Maruti Fence Installation Instructions or applicable building code; (b) the Product is misused, neglected or improperly stored; (c) the Product is altered or changed by applied heat, welding, solvents, epoxies, paint, or any other alteration beyond the manufacturer's control; (d) damage results from impact of objects, fire, flood, hurricane, tornado, wind storm, casualty or Acts of God; (e) the surface of the Product is painted; or (f) damage results from air pollution, mold, or Normal Weathering of surfaces. Maruti Fence does not recommend or approve its Products for every possible end use; the appropriate local code authority should be consulted regarding safety and suitability for the intended use, including pool-barrier and wind-load requirements of the Florida Building Code.

Product Changes

Maruti Fence reserves the right to discontinue or modify any Product, color or wood-grain finish without notice. Maruti Fence shall not be liable if a replacement Product varies in color or gloss from the original as a result of Normal Weathering, or because a Product has been discontinued or changed. Repaired or replacement Products may be substituted with products Maruti Fence determines to be of comparable quality or price range.

How to Make a Claim

Contact Maruti Fence directly — you bought from the manufacturer, so there is no dealer chain to go through. Call (407) 802-8997 or email info@marutifence.com. Provide your proof of purchase, a description of the defect, and photographs of the affected Product. Maruti Fence may request return of the affected parts or an inspection before honoring a claim.

THE STATEMENTS CONTAINED IN THIS LIMITED WARRANTY SET FORTH THE ONLY WARRANTIES EXTENDED BY MARUTI FENCE AND ARE IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE PROVISIONS OF THIS WARRANTY CONSTITUTE THE ENTIRE LIABILITY OF MARUTI FENCE AND THE PURCHASER'S EXCLUSIVE REMEDY. TO THE EXTENT PERMITTED BY APPLICABLE LAW, MARUTI FENCE SHALL NOT BE LIABLE TO THE PURCHASER FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES FOR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY ON THE PRODUCTS. SOME STATES DO NOT ALLOW LIMITATIONS ON IMPLIED WARRANTIES OR THE EXCLUSION OF INCIDENTAL OR CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATIONS MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS, AND YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE.

This warranty applies to Maruti Fence products purchased on or after July 1, 2026.
